CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “Millennium Pacific Group Holdings Limited” to “YUNJING DIGITECH GROUP LIMITED”, and the dual foreign name in Chinese of the Company from “匯思太平洋集團控股有限公司” to “雲晶數智科技集團有限公司”.

CHANGE OF STOCK SHORT NAMES

The English and Chinese stock short names for trading in the Shares on the Stock Exchange will be respectively changed from “MILLENNIUM PG” to “YUNJING DIGITECH” in English and from “匯思太平洋” to “雲晶數智” in Chinese, both with effect from 9:00 a.m. on 13 August 2026. The stock code of the Company on the Stock Exchange will remain unchanged as “8147”.

Reference is made to the announcement of YUNJING DIGITECH GROUP LIMITED (formerly known as Millennium Pacific Group Holdings, the “**Company**”) and the circular (the “**Circular**”) of the Company both dated 29 May 2026 in relation to, among other things, the Proposed Change of Company Name and the announcement of the Company dated 22 June 2026 in relation to the poll results of the annual general meeting of the Company held on 22 June 2026 (“**AGM**”). Capitalised terms used in this announcement shall have the same meanings as those defined in the Circular unless the context herein requires otherwise.

CHANGE OF COMPANY NAME

The Board is pleased to announce that subsequent to the passing of a special resolution approving the Proposed Change of Company Name by the Shareholders at the AGM, the Registrar of Companies in the Cayman Islands has approved the registration of the new names of the Company and issued the Certificate of Incorporation on Change of Name on 29 June 2026, certifying respectively that on 29 June 2026, the English name of the Company

has been changed from “Millennium Pacific Group Holdings Limited” to “YUNJING DIGITECH GROUP LIMITED”, and the dual foreign name in Chinese of the Company from “匯思太平洋集團控股有限公司” to “雲晶數智科技集團有限公司”.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Companies Registry in Hong Kong on 20 July 2026, confirming the registration of the Company’s new English and Chinese Company names of “YUNJING DIGITECH GROUP LIMITED” and “雲晶數智科技集團有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

EFFECTS OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders and the trading of the shares of the Company (the “**Shares**”) on the Stock Exchange or the daily business operations of the Company and its financial position. All existing share certificates of the Company in issue bearing the former name of the Company will continue to be effective and as evidence of title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates bearing the new name of the Company. Any new share certificate of the Company will be issued in the new name of the Company.

CHANGE OF STOCK SHORT NAMES

The English and Chinese stock short names for trading in the Shares on the Stock Exchange will be respectively changed from “MILLENNIUM PG” to “YUNJING DIGITEC” in English and from “匯思太平洋” to “雲晶數智” in Chinese, both with effect from 9:00 a.m. on 13 August 2026. The stock code of the Company on the Stock Exchange will remain unchanged as “8147”.
